## A LETTER FROM THE CHAIRMAN

Dear friends,

Education Together Foundation’s first annual Legacy Gala on October 1, 2011, was held at the beautiful Paradise Springs Event Center in Monroe. Attendees dined on a choice of four entrees catered by OSU Catering, danced to the music of a live band, and donated generously for ETF’s programs. The gala proceeds enabled ETF to establish its new Legacy Fund, which awarded four \$2000 scholarships to Junction City students continuing their college education. This year’s gala promises to be even more festive on September 29, 2012.

Our traditional Awards Night took place on May 15, 2012 at the First Baptist Church in Junction City. A total of \$64,550 in scholarships and grants was awarded at this event, going to 51 deserving students and numerous community educational organizations. Our thanks go to the First Baptist Church, Safeway Stores, and Pepsi Corporation for their support of this event.

In addition, ETF awarded \$15,000 in Chichester-duPont Adult Career Education grants during the 2011-12 fiscal year to local adults seeking job-specific training.

Several new funds were established by ETF during the fiscal year, including one new endowment (see the story below). ETF now has 31 endowment funds invested with Oregon Community Foundation, and 30 annual Scholarship and Memorial funds

We know you share in our pride in ETF’s accomplishments and we look forward to your continuing support as we celebrate 25 years of giving to education in Junction City.

## NEW FUNDS INAUGURATED

Several new scholarship funds were established in FY 2011-12.

The **Jim Paull Memorial Annual Scholarship Fund** was converted to the **Jim Paull Memorial Endowment** in 2012 thanks to a generous contribution from a donor. The goal of the endowment remains to support health and health education in the Junction City School District, particularly at the elementary school level.

Ellie Dumdi established the **Cleve Dumdi Memorial Scholarship**, to be awarded annually to a JCHS senior pursuing college study in agriculture, or, if no agriculture student is selected, a student attending Oregon State University.

The **Dr. John and Stacy Hunts Scholarship** was initiated by John and Stacy Hunts, and will award a scholarship to a student pursuing a degree in science, health care or engineering.

The new **Kymo Timber, Inc.** annual scholarship is intended for applicants pursuing a course of study related to forestry.

**UnwiredWest Internet Inc.** established an annual scholarship aimed at students in a technology or music program.

All of these new funds made awards in May, 2012, and the new **ETF Legacy Fund** also awarded its first scholarships in 2012.

## TIGER ALUMNI SCHOLARSHIP FUND AWARDS

In 1999, dedicated ETF Board Member Pam Fiske (class of 1974) was instrumental in the formation of the Tiger Alumni Fund Endowment. Hundreds of alumni, parents and grandparents, along with golf tournament proceeds, have provided more than \$150,000 to this fund. Since 2000, the Tiger

Alumni Fund has given 51 scholarships to students who are the children of JCHS alumni .

In 2012, the Tiger Alumni Fund awarded four \$1000 scholarships, to **Linzey Gifford** (father Billy Gifford ('82')); **Adam Johnson** (parents Tim & Gennett Fielder Johnson ('86), great-grandfather Everett Graville ('41)); **Brandon Nelson**

father Doug Nelson ('78), grandfather Bob Nelson ('51), grandmother Marjorie Lingo Nelson ('52), and great grandmother Mary Agnes Freeman); and **Britniann Ward** (mother Angie Crowley Norris ('87), grandfather Larry Crowley ('62) and grandmother Linda Kowalski Crowley ('65)).

## EDUCATIONAL PROGRAMS & PROJECTS AWARDS

Jim Paull Memorial awarded \$500 to the Laurel Elementary Health Department.

Long Tom Grange awarded \$700 to Territorial Elementary School for media center cabinets, an inflatable

play structure, and ground cover, and \$700 to Oaklea Middle School for a projector.

## ADULT CAREER EDUCATION GRANTS

Funds available through the Chichester-DuPont Foundation grant for Adult Career Education were used to provide \$15,000 in grants to twelve adults seeking to enhance their career potential through practical training. The

students were each pursuing training in Nursing or seeking to qualify as Emergency Medical Technicians.

The Chichester Foundation provided \$20,000 in late 2010 for expenditure over a two-year period, and another

\$20,000 to be invested. The Investment proceeds can be used to fund additional grants beginning in 2013.

## COMMUNITY AND SCHOOL GRANT AWARDS

The ETF Community and School Grant Endowment was established in 2002, and has been funded primarily through grants from the Chichester-DuPont Foundation, although individuals have contributed to this endowment as well.

Grant funds of \$6,500 have been earmarked for awards to be made in the 2012-13 fiscal year. The funds will be allocated to community agencies such as the Junction City Public Library, Viking Sal Senior Center, Junction City Community Center, Junction City Historical Society and ETF's Adult

GED Program.

School grants will be allocated based on enrollment among Territorial and Laurel Elementary Schools, Oaklea Middle School and Junction City High School in 2012-2013.

These funds are invested with The Oregon Community Foundation; investment earnings are used to fund scholarships and to increase the fund's equity.

Annual Scholarship Donations are given yearly by individuals or businesses for a specific amount, to fund one or more annual scholarships. An annual administrative fee of \$50 is charged for the first scholarship awarded from each fund, with a 2% fee for any additional scholarships in a given year.

Education Together's **overall fund balance** decreased by 4.8% during Fiscal Year 2011-2012, due largely to market decreases and the expenditure of the one-time Adult Career Education grant from the Chichester-DuPont Foundation. ETF's assets still totaled over \$1,000,000 as of June 30, 2012, with 88% held in Oregon Community Foundation endowment funds.
